**REGULATIONS**

Only two coffins are allowed per burial plot (however CR or NVF may be added)  
No pre-purchase of burial plots is allowed  
Children's coffins of over 1.17 metre (3' 6") in length will have to be interred in an adult burial plot

**Before your clients commit to a burial at this Burial Ground please make them aware that the Burial Ground is a lawned cemetery and that all memorials have to be approved before erection. Furthermore vases or any other tributes are not allowed unless they form part of the approved headstone.**

Restrictions apply to size and construction of headstones/memorials - please apply to office for details. Notwithstanding, all memorials must be fixed in accordance with NAMM Working Code of Practice and conform to BS8415

Please note that an individual who was a resident of Anston immediately prior to taking up residence in a home, hospital or hospice is still classed as a resident of Anston.

\* For memorial wall plaques the price is based on either the applicant or the deceased being a resident, former resident or non-resident.
