The Chairman initiated discussion on the condition of the Parish Hall and its future uses. The Clerk reported that he awaited an updated condition survey of the Hall from CS Surveying.

RESOLVED: That a public consultation event on the future of the Parish Hall be held on Saturday 27th April. Cllr Manship prepare some draft consultation questions for consideration at the next meeting of the Committee and that electronic copies of the existing hall plans be circulated to councillors.

12.19 CONDITION OF THE BOWLING GREEN AND RELATED FACILITIES

The Chairman initiated a discussion on the condition of the bowling green and related facilities. A variety of issues were raised by councillors and members of the public present. It was felt that the Charity working with the bowling club was in a strong position to apply for funding from Sport England and other funders.

RESOLVED: That this be noted and the bowling club and football team using the recreational ground be consulted on the future of the bowling green and Parish Hall.

Cllr Manship reported that he had attended the South Yorkshire Funding Advice Bureau event held in Sheffield on Thursday 7th February and found it to be very informative. From what he had learnt at the event he emphasised that funders would expect applications to demonstrate how projects would serve local people.
