

NOTICE OF ELECTION

Election of the Mayor for the South Yorkshire Mayoral Combined Authority

1. An election is to be held for the Mayor for the South Yorkshire Mayoral Combined Authority.
2. Nomination papers can be obtained from the office of the Combined Authority Returning Officer, 11 Broad Street West, Sheffield S1 2BQ, during normal office hours.
3. Nomination papers must be delivered to the Combined Authority Returning Officer, South Yorkshire Mayoral Combined Authority Office, Room G1, Ground Floor, 11 Broad Street West, Sheffield S1 2BQ, between **10am and 4pm** on any working day after publication of this notice but no later than **4pm on Tuesday 5 April 2022**.
4. If the election is contested the poll will take place on **Thursday 5 May 2022**.
5. Applications to register to vote must reach the relevant Electoral Registration Officer by **Thursday 14 April 2022** if they are to be effective for the election. Applications can be made online: www.gov.uk/register-to-vote.
6. Candidates must pay a deposit of £5000 which must reach the Combined Authority Returning Officer by **4pm on Tuesday 5 April 2022**. The deposit can be paid by legal tender, debit/credit card or by means of a banker's draft, banker's order or building society cheque (payable to The South Yorkshire Passenger Transport Executive which is acting as agent for the Combined Authority Returning Officer).
7. To be included in the Mayoral Booklet, a candidate's election address which complies with all legal requirements together with a payment of £3150 (acceptable payment methods are as at 6. above) must be received by the Combined Authority Returning Officer by **4pm on Tuesday 5 April 2022**.
8. New applications for postal votes and applications to change or cancel existing absent voting arrangements must reach the relevant Electoral Registration Officer by **5pm on Tuesday 19 April 2022**.
9. Applications to vote by proxy at this election must reach the relevant Electoral Registration Officer by **5pm on Tuesday 26 April 2022**.
10. Applications to vote by emergency proxy at this election must reach the relevant Electoral Registration Officer by **5pm on Thursday 5 May 2022**. To be eligible for an emergency proxy vote, the emergency preventing attendance at the polling station **must have occurred after 5pm on Thursday 26 April 2022** and the applicant must have been unaware until after that time that they would be unable to attend the polling station.
